Introduction

RPH The Hoist People Ltd (the "data controller") takes the privacy of your personal information very seriously and is committed to safeguarding your privacy and your personal information, complying with the Data Protection Act 2018 and the Privacy and Electronic Communications Regulations 2003. This Privacy Policy relates to our use of any personal information we collect from you directly, or indirectly via 3rd party data providers, covering individuals who:

- use our goods and services;
- contact us concerning our goods and services;
- attend or register to attend our events (including online events) or other events in which RPH The Hoist People Ltd participates;
- complete surveys RPH The Hoist People Ltd has issued or commissioned;
- complete competition entries RPH The Hoist People Ltd has issued or commissioned;
- through telephone research of your organisation and your role in the organisation;
- through research of public resources to identify organisations and your role in the organisation;
- supply goods or services to RPH The Hoist People Ltd;
- have applied to work for RPH The Hoist People Ltd, or are a current or former employee of RPH The Hoist People Ltd.

This Privacy Policy will explain the following:

- what personal information may be collected about you;
- how RPH The Hoist People Ltd will use this personal information;
- when RPH The Hoist People Ltd may use this personal information to contact you;
- how long will RPH The Hoist People Ltd retain your personal information;
- how this personal information may be shared with other parties;

In this Privacy Policy, personal information means information relating to an identified or identifiable natural person. An identifiable person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, and online identifier or to one or more factors specific to his/her physical, physiological, genetic, mental, economic, cultural or social identity.

We do not knowingly collect personal information relating to children.

RPH is not responsible for the privacy statements or other content on websites which are not owned or run by RPH The Hoist People Ltd.

What personal information is held about you and how we use it?

- We will only use your personal data when the law allows us to. Most commonly, we will use your personal data in the following circumstances:
- Where we need to perform the contract we are about to enter into or have entered into with you.
- Where it is necessary for our legitimate interests (or those of a third party) and your interests and fundamental rights do not override those interests.
- Where we need to comply with a legal or regulatory obligation.

Personal information that you provide to us.

1. Users of our goods and services

RPH The Hoist People Ltd collects personal information from you when you use our goods or services, including name, email address, postal address, telephone number and job title.

We will use this personal information:

2. Individuals contacting us concerning our goods and services

RPH The Hoist People Ltd collects personal information from you when you contact us about our goods or services or subscribe to our newsletters, including name, email address, postal address, telephone number and job title.

We will use this personal information:

- To send you personalised communications which you have requested or may be of interest to you. These may include information about publications, webinars, events, surveys, goods and service developments, and promotions of our associated brands' goods and services.
- RPH The Hoist People Ltd uses automated decision making and profiling to personalise and ensure the communications are relevant to you, with no significant effect on you or your rights.

3. Attendees or registrants to our events (including online events) or surveys, questionnaires or other events in which RPH The Hoist People Ltd participates

RPH The Hoist People Ltd collects personal information from you when you register at or register to attend an event hosted by or participated at by RPH The Hoist People Ltd. The personal information collected will include your name, email address, telephone number and job title.

We will use this personal information:

- To carry out our obligations arising from being a registered attendee of our event or other events in which RPH The Hoist People Ltd participates.
- To send you personalised communications which you have opted-in to receive. These may include information about publications, webinars, events, surveys, goods and service developments, and promotions of our goods and services.
- RPH The Hoist People Ltd uses automated decision making and profiling to personalise and ensure the communications are relevant to you, with no significant effect on you or your rights.

4. Companies who supply goods or services to RPH The Hoist People Ltd

RPH The Hoist People Ltd collects personal information from you when you supply goods or services to RPH The Hoist People Ltd, including name, email address, postal address, telephone number and job title.

We will use this personal information:

To carry out our obligations arising from you providing us goods or services.

Personal information provided to us by 3rd parties.

Visitors to our website

- When someone visits our website (www.rphhire.com) we use a 3rd party service, Google Analytics, to collect details of website traffic and visitor information, including browser type, internet service provider, URLs of referring/exit pages, operating system, date/time stamp, information you search for, locale and language preferences, identification numbers associated with your devices, your mobile carrier, and system configuration information. - We use the website traffic and visitor information to improve our understanding of the use of the RPH The
 Hoist People Ltd website and in order to determine what RPH The Hoist People Ltd goods and services are
 the most popular.

How long will we retain your personal information?

- We will retain and process your personal information as long as is needed to provide the goods or service that you have elected to receive from us.
- For personal information used by us for our own direct marketing purposes, we will retain the personal information whilst accurate or responsive and if not, no longer actively used after 5 years.

How will your personal information be shared?

We share information, including personal information, with trusted third-party service providers, that we use to provide hosting for and maintenance of our website, event management, customer relationship management, payment processing, support, accounts, analytics and other services for us. We do not permit our third-party service providers to use the personal information that we share with them for their marketing purposes or for any other purpose than in connection with the services they provide to us.

To facilitate these services the personal information we collect from you may be transferred to, and stored at, a destination outside the European Economic Area, in order to conduct our business operations. In such cases a data processing agreement will be in place with the data processors and 3rd parties to ensure your personal information is processed in accordance with the Data Protection Act 2018.

RPH The Hoist People Ltd will in certain circumstance disclose your personal information if required to do so by law or in the good faith belief that such action is necessary to:

- conform to the edicts of the law or comply with legal process served on RPH The Hoist People Ltd
- protect and defend the rights or property of RPH The Hoist People Ltd; and,
- act under exigent circumstances to protect the personal safety of users of RPH The Hoist People Ltd goods or services, or the public.

How is your personal information kept secure?

RPH The Hoist People Ltd is committed to protecting the security of your personal information. We will use a variety of security technologies and procedures to protect your personal information from unauthorised access, use or disclosure. Although we will do our best to protect your personal information, we cannot guarantee the security of your personal information transmitted to our site; any transmission is at your own risk. Once we have received your personal information, we will use strict procedures and security features to try to prevent unauthorised access.

RPH The Hoist People Ltd secures the personal information you provide on computer servers in a controlled, secure environment, protected from unauthorised access, use or disclosure. RPH The Hoist People Ltd ensures personal information is protected through the use of encryption, such as the Secure Socket Layer (SSL) protocol, when transmitted to other websites.

 or legal obligations, which we will complete bar keeping the minimal personal details to ensure we do not
 contact you again, free of charge.
